# Reduction of Cambodian Public Holidays in 2020

The Royal Government of Cambodia has announced to reduce the public holidays for civil servants and employees to 22 days in 2020 from 28 days in the previous years via the Sub-decree No. 112 SD.P dated 2 August 2019.

Started in early 2019, the initiative was raised to tackle the imbalance between working days, holidays and productivity. As of 2019, all employees in both public and private sectors are entitled to 28 days.

The reduction of holidays aims to enhance work efficiency, increase productivity and guarantee economic competition with the regional neighbours.

In 2020, the Khmer New Year public holiday will be increased to 4 days (from 3 days in the previous years), while the religious festival of Meak Bochea, the National Memorial Day, the International Children Day, the Paris Peace Accord Day and the International Human Rights Day will be eliminated. The public holiday for King's Birthday will be shortened from 3 days to 1 day in May. In total, 6 days will be cut off.


