## Reminder: Registration of Exporters on REX System by 31 December 2019

The Ministry of Commerce (“**MOC**”) has issued Notification No. 4228 MOC.EID dated 30 October 2019 (“**Notification**”) to alert all exporters who intend to export all kinds of goods to the European Union (“**EU**”) under the Everything But Arms (EBA) initiative and Generalised System of Preferences (GSP) of Norway, Switzerland and Turkey, to register on the Registered Exporter System (“**REX System**”) with MOC latest by 31 December 2019.

The Notification refers to Joint Prakas No. 1627 MEF.PrK dated 28 December 2018, which calls for registration on the **REX System** by exporters to enable self-declaration on the Statement on Origin in replacement of the old platform of the Certificate of Origin (Form A) issued by MOC.

Failure to register on the REX System will subject the exporters to applicable EU import duties.

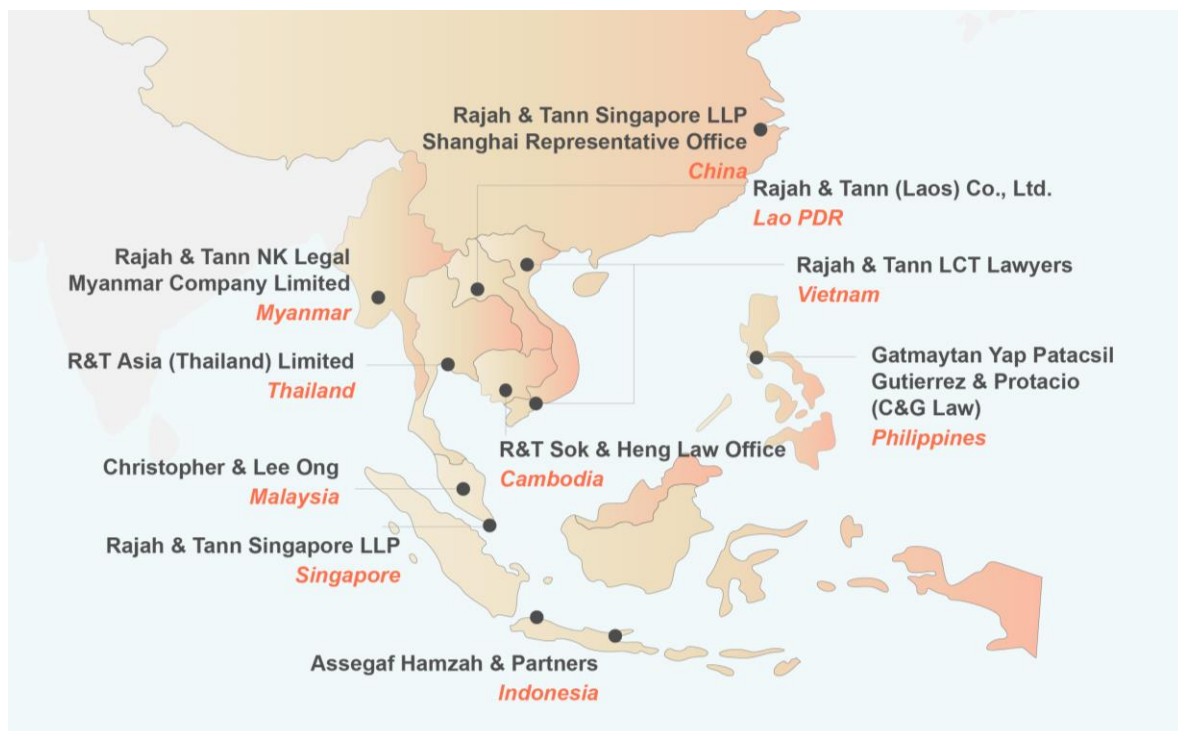
