Opening for Application for Mineral Exploration License of New Concession Areas

On 10 January 2020, the Ministry of Mines and Energy ("MME") issued Announcement No. 001 ME.DIM.SCN on the Opening for Application for Mineral Exploration License of the Concession Areas ("Announcement"). 
