Nationwide Travel Constraint for Preventing the Spread of COVID-19 and Exception for Certain Travels

The Royal Government of the Kingdom of Cambodia (“RGC”) has issued an Order No. 02 ORD dated 9 April 2020 on the Nationwide Travel Constraint for Preventing and Obstructing the Spread of COVID-19 (“Order”). Based on the Order, the constraint enters into force from 24:00 of 9 April 2020 to 24:00 of 16 April 2020 with the following stipulations:

1. Prohibition against nationwide travel, including travels across Phnom Penh (except travelling inside the city), and inter-district and inter-province travels.
2. This prohibition is not applicable to:
 - all goods being transported via roadway, waterway and railway;
 - vehicles and transportation of the civil servants of both the national and sub-national public institutions for conducting daily works, who must show their working IDs to competent authorities;
 - vehicles and transportation of all armed forces for carrying out their duties;
 - public and private ambulances;
 - firefighter trucks;
 - dustcarts or waste collection trucks;
 - workers being transported to factories-enterprises that have Workers Transportation Permits issued by the Ministry of Labour and Vocational Training or the Department of Labour and Vocational Training; and
 - citizens travelling to the nearest hospitals or health centres for necessary and urgent healthcare services, with a maximum number of four people in each case.

However, on 10 April 2020, the RGC issued Decision No. 39 DECIS to revise some constraints due to the needs of the people by allowing:

1. travelling between Phnom Penh and Kandal province; and
2. travelling inter-district within the same province.

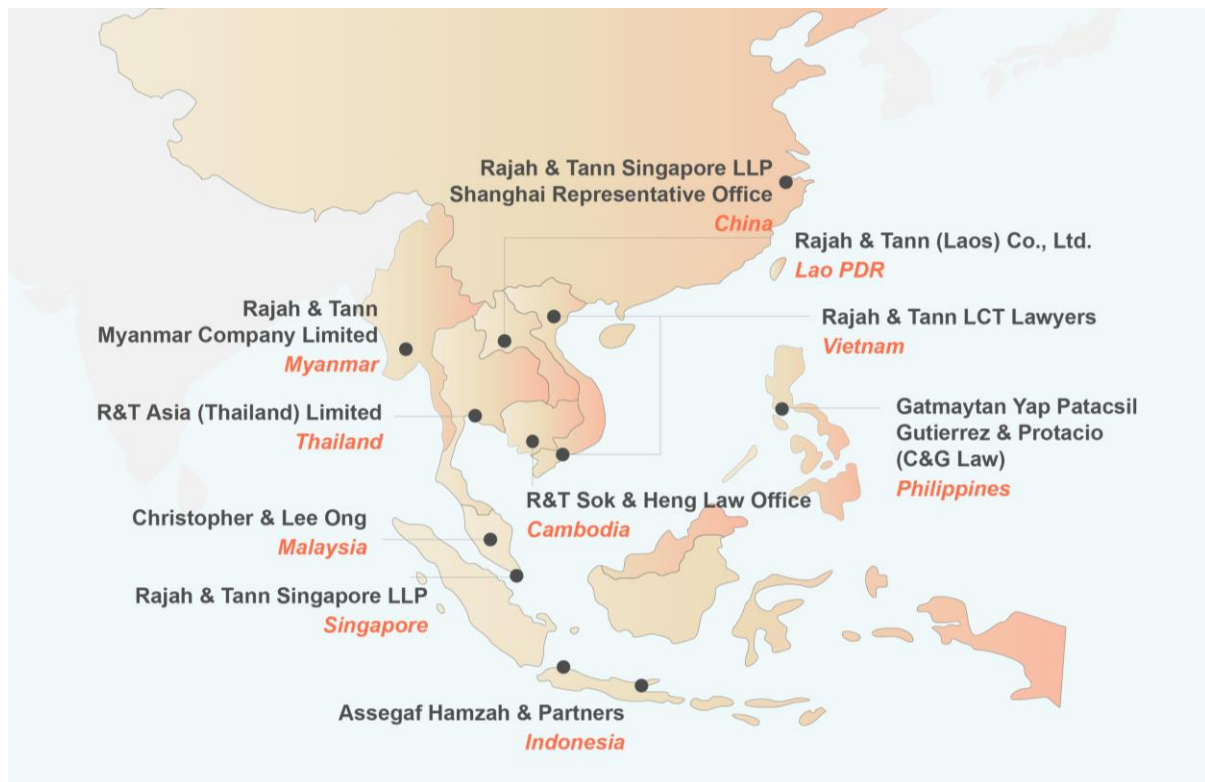
