Guideline on Health and Livelihood Protection of Cambodian International Migrants and Returnees During COVID-19 Containment

Guideline No. 048/20 MLVT on Health and Livelihood Protection of Cambodian International Migrants and Returnees During COVID-19 Containment was issued by the Ministry of Labour and Vocational Training on 29 April 2020 ("**Guideline**"). According to the Guideline:

Cambodian international migrants shall:

- follow the laws, orders and health measures issued by the competent authority of the residing country;
- follow the guidelines or notifications of the Embassy/Consulate of the Kingdom of Cambodia in the residing country;
- perform work as instructed by the competent authority and the employers; and
- immediately contact the Embassy or Consulate of the Kingdom of Cambodia for any emergency case.

Returnees:

- shall follow the guidelines of the competent authority at the land border and airport for health check measure implementation and 14-day quarantine after arrival;
- shall contact the local authorities for intervention if any problem affecting their daily livelihood during COVID-19 containment arises; and
- shall contact the Municipal/Provincial Department of Labour and Vocational Training and Employment Centre for new job information; and
- should help their family with farming and agricultural work while waiting to find a new job or to emigrate.


