COVID-19 Costs for Testing, Quarantine Facilitation and Treatment

Following notification No. 4898 MEF dated 8 June 2020 issued by the Ministry of Economy and Finance ("**MEF**") on the Costs of Foreign Travellers for COVID-19 Testing and Health Examination at Public Hospitals, the Ministry of Health ("**MOH**") issued notification No. 564 dated 11 June 2020 ("**Notification**") on the payment fees for COVID-19 tests and health examinations.

The Notification sets out the payment fees for foreign travellers arriving in Cambodia while waiting for the result of COVID-19 test release, the 14-day quarantine facilitation, health examination, and treatment. They are detailed in the following table:

No.	Service Description	Unit Price (US\$)
1.	COVID-19 Test (including collecting and sending specimen to laboratory, laboratory test and result)	100/person/time
2.	Issuance of health certificate	30/person/time
3.	Transportation	5/person/time
4.	Hospital rooms/ hotels/quarantine centres	30/night/person
5.	Treatment including medicine	Maximum 150/day/person
6.	Meal (three a day)	30/day/person
7.	Laundry service and/or cleaning	15/day/person
8.	Standby nurses for quarantine facilitation (package)	6/day/person
9.	Security (package)	3/day/person
10.	Funeral	1500/person
11.	Emergency	Per prevailing hospital service fees
12.	Health examination, existing chronic diseases treatment and others	Per prevailing hospital service fees

Foreign travellers are required to purchase a health insurance with a coverage of at least US\$50,000, and place a deposit of at least US\$3,000 with a commercial bank prior to his/her entry.

The Notification came into effect from 11 June 2020.


