## The Implementation of Health Measures and Quarantine for All Travellers Entering into Cambodia

To prevent the COVID-19 community spread, the Inter-Ministerial Committee to Combat COVID-19 has issued a press release No. 251 on the implementation of health measures and quarantine for all types of travellers entering Cambodia, effective from 12 December 2020 onwards ("**Press Release**").

According to the Press Release, the requirements for all travellers entering Cambodia are as follows:

- To undergo a mandatory full 14-day quarantine after being tested on arrival; and
- To provide a COVID-19 health clearance certificate issued by a competent health authority of the travellers' home countries with a validity period of 72 hours immediately prior to the travel.

As part of the measures, the Government of Cambodia has further decided as follows:

- To postpone the implementation of the Sponsorship Mechanism, that allows all inbound foreign travellers who are investors, businesspeople, company employees, experts, and technicians being sponsored to enter into Cambodia, for at least 14 days until further notice (please refer to our previous [Client Update](#) on the Sponsorship Mechanism);
- To immediately disclose the identity of COVID-19 patients through official communication channels of the Ministry of Health to allow for immediate tracing of individuals who may have come into contact with the patient (to-date, according to the [speech](#) on 10 December 2020 of Her Excellency Or Vandine, the Secretary of State of the Ministry of Health, the disclosure of the patient's identity is limited to the patient's name, and such disclosure will be halted once the situation is under control); and
- The Prime Minister Volunteer Medical Team to assist with the samples collection, information dissemination, and community training about the COVID-19 pandemic.

All the requirements above are in effect from 12 December 2020 onwards until further notice by the Royal Government of Cambodia.

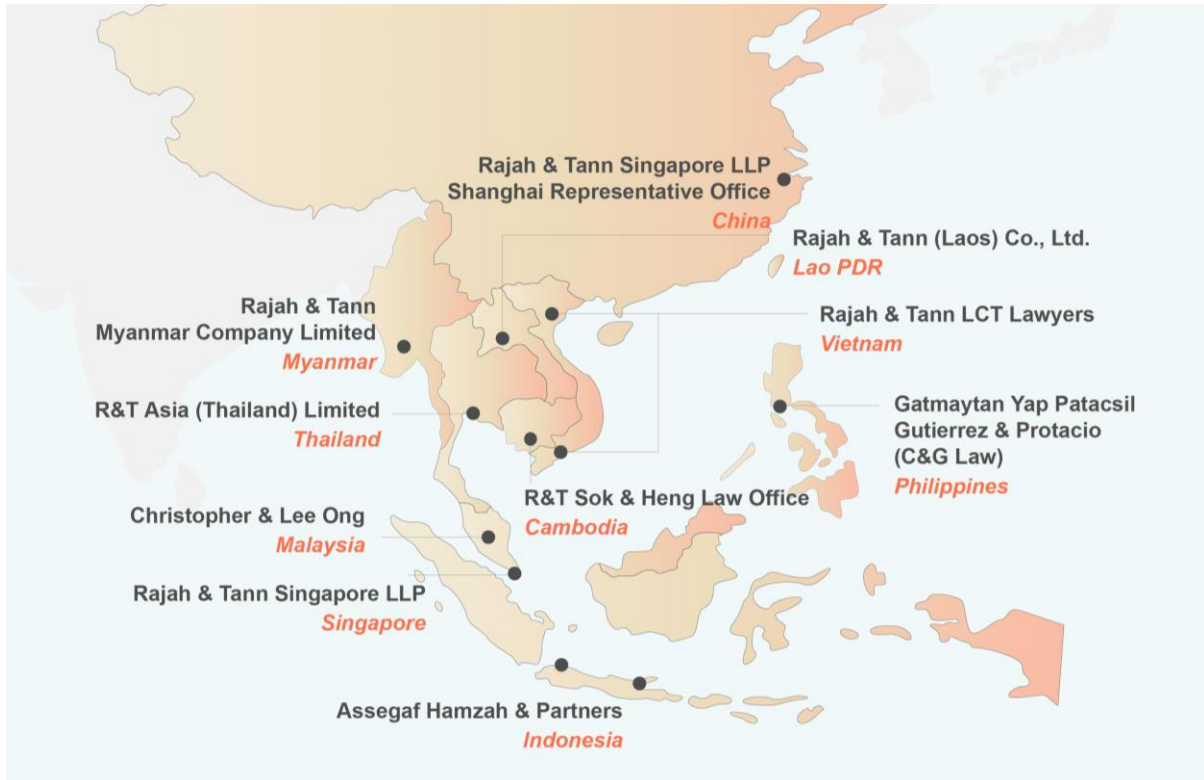
