Extension of the 2021 Foreign Employees Quota Application

The Ministry of Labour and Vocational Training ("**MLVT**") has issued Notification No. 041/20 dated 9 December 2020 on the Extension of the 2021 Foreign Employees Quota Application ("**Notification**").

According to the Notification, the MLVT has extended the period to file the application to request for foreign employees quota for 2021 to the end of January 2021 for all factories/enterprises. The owner/director of any factory/enterprise who intends to use foreign employees in 2021 shall submit the application by 31 January 2021 at <u>FWCMS online system</u>. Non-compliance with the foreign employees quota may result in penalty under chapter 16 of the Labour Law.
